## **COUNTRY TEAMS CHAMPIONSHIP 2004**

- 1. This championship is a section of the State Open Teams Championship. The Country Teams Championship Final will be held at Port Macquarie Bridge Club on Saturday 30<sup>th</sup> and Sunday 31st<sup>th</sup> October 2004 and the winners are eligible to play in the State Open Teams Final on the weekend starting on Friday 26th November. Clubs will not be required to pay entry fees to the State Open Teams *Finals*.
- 2. The FABC, on behalf of the Tournament Committee of the New South Wales Bridge Association, invites all non-Metropolitan affiliated clubs to conduct one or two qualifying sections for this championship in order to qualify one or more teams to play in their Regional Final. Clubs may run a daytime section and/or an evening section.
- 3. A list of Regions/Clubs is enclosed. Any clubs not included on this list should contact the convenor.
- 4. Clubs not wishing to run a qualifying competition may nominate one team per 50 home club members or part thereof with a limit of three teams. Each nominated player must be a financial member of the nominating club.
- 5. Player entry fees will be \$1 per player per session in the qualifying rounds. If a club nominates a team or teams in accordance with section 3 there will be a nomination fee of \$75 per team.
- 6. The tournament regulations are enclosed. Please read them carefully, as it is your responsibility to adhere to these regulations. Extra copies are available if required. A copy should be given to each team that represents your club in the Regional Final. If any problems occur in the interpretation of these regulations please consult the convenor.
