- 1. The FABC, on behalf of the Tournament Committee of the New South Wales Bridge Association, invites all affiliated Metropolitan clubs to conduct a qualifying section for the State Open Teams Championship in order to qualify one or more teams to play in the Metropolitan Final.
- 2. This Championship is a section of the State Open Teams Championship. The Metropolitan Final will be held on Sunday 19 September 2004. - 3. Clubs not wishing to run a qualifying competition may nominate one team per 50 home club members or part thereof with a limit of three teams. Each nominated player must be a financial member of the nominating club.
- 4. The Metropolitan Final will be held at the Lindfield Bridge Club (same as last year) on Sunday 19 September 2004, starting at 9.30am. Table money will be \$120 per team (see "Masterpoints and Results regarding payment). Please advise finalists that lunch will be provided.
- 5. Player entry fees will be \$1 per player per session in the qualifying rounds. If a club nominates a team or teams in accordance with section 3, there will be a nomination fee of \$75 per team.
- 6. The Tournament Regulations are attached. Please read them carefully. It is your responsibility to adhere to these regulations. A copy of the regulations should be given to each team that qualifies to the Metropolitan Final. If any problem arises over the interpretation of the regulations, please consult the convenor.
